
From the main screen, press and hold for 3 seconds to view 5 watch interface choices. Swipe across and tap the interface of your choice to select.

HOW TO OPERATE

Power Button:

1. Press and hold to power ON/OFF

2. Quick press to turn screen ON/OFF

Swipe Left: Go to next screen

Swipe Right: Go to previous screen Swipe Up: On the main screen, swipe

up to quickly view data Swipe Down: On the main screen, swipe down to enter the setup menu

To change watch bands:

- Slide pin B into hole in watch base.
- 2. Slide peg A inward to retract opposite pin, and fit into hole in the watch base. Make sure the pin snaps into place to hold the band securely. Repeat for other band.
